## Contribution Guidelines

### Membership

There are two types of membership: supporting membership and voting membership, which entitles to participate in general meetings. Individuals and legal entities interested in voting membership should indicate their interest here. Formal admission will occur at the next general meeting. (We recommend supporting membership, as general meetings and other committee meetings are held in German.) For companies, the membership fee is determined based on self-assessment. The minimum amount is based on the number of employees.

25 – 249 employees	€750
250 – 499 employees	€1,000
500 – 2,499 employees	€1,500
2,500 – 4,999 employees	€3,000
from 5,000 employees	€5,000
